

# Entrance examination at the Maritime University of Szczecin

2026/2027



## 1. Candidates required to take the exam

Only candidates who apply for admission to undergraduate programmes on the basis of a secondary school **certificate/diploma obtained outside the European Union, OECD, EFTA, Ukraine or China** are required to take the entrance examination. MUS Admissions staff shall verify candidates' credentials and inform them if they are obligated to take the exam. The information will be sent via the online application system to the e-mail address provided during the candidate's registration.

## 2. Scope of the exam

The exam will cover the following issues in mathematics:

- 1) operations on algebraic expressions,
- 2) operations on fractions, powers, roots,
- 3) linear function – graphs, properties, solving equations and inequalities,
- 4) quadratic function – graphs, properties, solving equations and inequalities,
- 5) polynomial and rational equations,
- 6) acute angle trigonometric functions,
- 7) transforming mathematical formulas
- 8) solving systems of equations,
- 9) unit conversion.

## 3. Form of conducting the exam

3.1 The exam will be conducted:

- 1) in Polish - for candidates applying for admission to studies in Polish,
- 2) in English - for candidates applying for admission to studies in English.

3.2 The exam will be conducted online **on the Moodle platform**. The university provides candidates with the necessary log-in data and instructions.

3.3 For the whole duration of the exam candidates are expected to **connect with MUS staff by means of MS Teams with a webcam, microphone and speakers on** so as to allow proctoring the exam.

3.4 Candidates are expected to complete the examination on their own and within the specified time.

## 4. Exam dates

4.1. The exam will be conducted on **10 July 2026**.

4.2. If additional admission rounds are opened, the next planned exam dates are **29 July 2026** and **4 September 2026**.

4.3. Taking the examination on 10 July 2026 can only be possible on the condition of completing the following formalities:

- 1) registering in the online admission application system and paying the application fee by 6 July 2026
- 2) by 6 July 2026 uploading at least one's secondary school diploma/certificate
- 3) on 8 July 2026 having a **mandatory test connection** with the university (test connection instructions will be sent on 6 July 2026).

## 5. Technical requirements

Meeting the following technical requirements is a prerequisite for taking the examination:

- 1) access to a **fixed Internet connection** with a minimum download speed of 10 Mbps and an upload speed of at least 2 Mbps
- 2) access to a computer equipped with **speakers, microphone and a webcam** (built-in or external). In the absence of those, video connection via a smartphone is required
- 3) using one of the **recommended browsers: Chrome, Edge, Firefox or Safari** web browser. The browser must be updated to the latest version, without any plugins installed, incognito access recommended.
- 4) access to the **Microsoft Teams application** from the browser or through a dedicated application. Hardware requirements for Teams are provided by Microsoft:

## 6. The examination

- 6.1. The examination shall last 55 minutes.
- 6.2. The exam is composed of 18 randomly selected single- or multiple-choice questions
- 6.3. The examinee should be in an empty and quiet room that provides the conditions for taking the examination alone and uninterrupted. There must be no other persons in the room.
- 6.4. It is compulsory for all examinees to have their webcam and microphone on at all times during the examination
- 6.5. The identity of the examinee will be verified on the basis of the passport scan (personal data page) sent to the university in advance.
- 6.6. The candidate may not stop the examination or move away from the computer during the examination.
- 6.7. Examinees may not ask any questions of the exam supervisors during the examination.
- 6.8. In the event of reasonable doubt on the part of the exam supervisor about the candidate's independent performance, the University may ask for a photograph of the notes to verify the calculations.
- 6.9. In the event of a computer, camera, microphone or network failure, the examination must be repeated.
- 6.10. If the supervisor finds that the candidate is performing the tasks in a fraudulent manner (e.g. with the help of third parties), the examination for that person is deemed to have been failed.
- 6.11. A repeat of the examination may be arranged in the form of a one-to-one interview with the examiner using MS Teams.

## 7. Exam result

- 7.1. To pass the examination candidates must obtain a minimum of **50%** of the possible number of points.
- 7.2. Candidates will be informed about the result of the exam via the online application system to the e-mail address provided during registration.
- 7.3. Only candidates with a positive exam result will be allowed to proceed to the next stage of university admissions.
